Course Description:

In this course the principles of physical and historical geology are applied to the study of the geology and mineral resources of Florida. One in-class exam will assess student understanding of geologic process and the Geology of Florida. Additionally, students will write a paper (~10 pages) on some aspect of Florida geologic history and give a ~15-minute powerpoint presentation on the topic during the last week of classes.

General education: GLY4155C, The Geology of Florida, is a GenEd physical science (P) course. Physical science courses provide instruction in the basic concepts, theories and terms of the scientific method in the context of the physical sciences. Courses focus on major scientific developments and their impacts on society, science and the environment, and the relevant processes that govern physical systems. Students will formulate empirically testable hypotheses derived from the study of physical processes, apply logical reasoning skills through scientific criticism and argument, and apply techniques of discovery and critical thinking to evaluate outcomes of experiments.

Course Goals and/or Objectives: When you complete this course you will be able to:

• Demonstrate understanding and ability to apply important concepts and skills established as goals in previous geological sciences coursework.

- Demonstrate an understanding of Florida's geologic history, the events and processes that shaped it past and present, and be able to place that history into context of the relevant global geologic history and events.
- Apply knowledge and skills attained from geological sciences BA degree curriculum coursework to analyze and communicate to others the geologic history of Florida.
- Put into practice fundamental data analysis and communication skills necessary to the successful geoscience professional including the ability to work in a group context.
- Demonstrate awareness of different Florida-related geoscience research topics.

Attendance Policy: Students are expected to attend class and participate in class discussions. Attendance and participation comprise 25% of your overall course grade.

Course Paper: Each student will a theme that they will study and report on in the form of a term research paper that details aspects of Florida's geologic history. Students will also share their findings with the rest of the class through a powerpoint presentation.
