COURSE DESCRIPTION

This course is designed to expose students to a broad spectrum of topics in Earth, Ocean, Atmosphere and Planetary Sciences. Seminar speakers will talk about their recent research achievements and other related topics. (*N.B. During the Spring 2023 semester, most of our seminar speakers will be candidates who are interviewing for one of the three open faculty searches that we are currently conducting.*)

Course Objectives: It is the goal of this course that students will:

- Learn about cutting edge research in Earth, Ocean, Atmosphere and Planetary Sciences.
- Briefly convey the primary "take-home" messages from the lectures, in written form

COURSE MATERIALS

There are no specified materials for this course, though some speakers may choose to make selected articles available

ASSESSMENTS AND GRADING

Grades will be based on submission of 10 brief seminar reports during the semester, one for each speaker. If, for some reason, we don't have at least 10 speakers, then the number of required reports will change accordingly. Requirements for seminar summaries are outlined below:

1) After each seminar, write a short (one-page, double-spaced) report, listing and briefly discussing the most important points of the presentation. Ten (10) reports are due over the course of the semester. Each report will be due prior to the following week's seminar (e.g. a report on the Sept. 1 seminar is due before 3:30pm on Sept. 8). 10 points (from a possible 100) will be deducted for each week that the report is late.

- 2) A list of speakers is posted on the Geological Sciences website and titles will be posted as they are received: http://geology.ufl.edu/seminarseries/
- 3) Most seminars will be hosted by Geological Sciences, but now and then we may designate a seminar hosted by another department or center (e.g. Biology, Water Institute, Climate Institute) as our official seminar for the week. The same reporting guidelines apply.
- 4) Upload the report (**as a .pdf**) to the GLY 6931 Canvas page before the following week's seminar see example in 1) above. Include your name and the speaker's name in the frontmatter of your report.
- 5) If you cannot join a seminar and have a reasonable conflict, contact me to arrange a make-up or substitution. It may be possible to substitute another seminar if you arrange to do so ahead of time, and if you identify interesting seminars in other units, by all means, attend them. But it is expected that you attend GLY seminars, as we want to show speakers the courtesy of our presence.

In-Class Recording

A "class lecture" is an educational presentation intended to inform or teach enrolled students about a particular subject, including any instructor-led discussions that form part of the presentation, and delivered by any instructor hired or appointed by the University, or by a guest instructor, as part of a University of Florida course. A class lecture does not include lab sessions, student presentations, clinical presentations such as patient history, academic exercises involving solely student participation, assessments (quizzes, tests, exams), field trips, private conversations between students in the class or between a student and the faculty or lecturer during a class session.

Publication without permission of the instructor is prohibited. To "publish" means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
